Don't fall victim to the latest telephone scam!

The Milford Police Department has received complaints regarding a phone fraud involving local Milford businesses.

The caller purports to be from a local electric utility provider, pressuring business representatives to provide payment to them regarding an outstanding account balance or their electrical service will be disconnected. The victim is told to purchase a reloadable debit card and then provide the scammer with the identification number off the rear of the card as the form of payment. Once this information is provided, it is very difficult to trace resulting in the victim suffering a financial loss.

Utility service providers, reloadable debit card services and money wiring businesses have information available on their websites regarding scams and how to protect yourself from becoming a victim to a fraudster.

- Police are encouraging anyone who receives phonecalls, emails or mail similar in nature to avoid responding to the fraudster and report the information to their local police department.
- Do not provide any personal or business financial information to the fraudster.
- Be suspect of people requesting payment by way of reloadable debit cards or money wiring services.
- Verify the legitimacy of the contact with your service providers.



Travelling this summer? Here are some tips for your safety and convenience.

- 1. The Milford Bank is a member of the Allpoint ATM Network. As a member, we can offer you free access to over 55,000 ATMs worldwide. To find out where to find Allpoint ATMs at your destination, check www.allpointnetwork.com/. You can also find mobile ATM locator apps there.
- 2. If you are travelling overseas, please inform the Bank before you leave. For safety reasons, ATM and Debit Cards used in foreign locations without advance knowledge by your financial institution may result in your inability to access funds in your account.
- 3. Going to be away from home for a while? You might want to consider estatements. With estatements, you receive access to your monthly transaction history the day after your statement closes—no more waiting for your information to be printed and mailed to you. And, if you are travelling, no need to worry about someone stealing financial information out of your mailbox.
- 4. Use PopMoney to send or receive money from anyone using your mobile phone. Travelling with friends? No need for separate checks! Simply send them your half of the bill or request.
